**Privacy Policy**

**1. GENERAL PRINCIPLES**

Worldwide Transcripts Private Limited (hereinafter referred to as 'Worldwide Transcripts' or 'Company' or 'We' or 'Us' or 'Our') has developed for the benefit of the user (hereinafter referred to as 'you' or 'your' or 'your of its Website or Mobile Application <http://www.worldwidetranscripts.com> (the website) and by this privacy policy ("Privacy Policy") we demonstrate our commitment to protecting the privacy of the information that we collect through the Website or Mobile Application. This Privacy Policy summarizes how Worldwide Transcripts handles the personally identifying information that you voluntarily provide when you use the website or mobile application and that we may automatically collect when you visit the Website ("Personal Information"). Worldwide Transcripts strives to protect your Privacy and Personal Information in order to gain your trust and confidence.

If you are accessing, using or browsing this Website or mobile application either for self or on behalf of an individual other than yourself, which may be either a natural person or an entity other than yourself:

- You represent, warrant and covenant that You are at least age 18;
